The Vernon Parish Police Jury met for the Organizational meeting, Monday, January 8, 2024 at 11 a.m. in the Police Jury meeting room with the following members **PRESENT**: James B. The Vernon Parish Police Jury was convened as the governing authority of the Parish of Vernon, by Mr. James B. "Jim" Tuck, President, and was then ready for the business on the agenda.

The invocation was given by Mr. Curtis Clay and the Pledge of Allegiance was led by

Mr. Charnel Bailey.

The President asked if there was any public comment on any agenda items; there was none.

The first item on the agenda was the election of officers.

A motion was made by Mr. Bailey, seconded by Mr. Hilton, to nominate Mr. James B. Tuck for President. There were no other nominations. A motion was made by Mr. Haymon, seconded by Mr. Roshong to cease nominations.

By acclimation, Mrs. Plummer was elected at Treasurer for a two (2) year term.

A motion was made by Mr. Brister, seconded by Mr. Clay and carried, to adopt a resolution establishing the meeting schedule of the Vernon Parish Police Jury for the year 2024.

A motion was made by Mr. Hilton, seconded by Mr. Thompson and carried, to accept the minutes of the December 11, 2023 Committee meeting, the December 18, 2023 Regular meeting, and the December 28, 2023 Special Call meeting and dispense with the reading of the minutes.

A motion was made by Mr. Brister, seconded by Mr. Thompson and carried, to enter into public hearing to hear public input on a proposed ordinance to authorize the sale of adjudicated property to B & J Limited Properties for \$29,000.00; B & J Limited Properties is the adjoining property owner and has maintained the property for several years. This property was previously declared surplus by the jury.
