The Vernon Parish Police Jury met in Regular Session, Monday, March 18, 2024 at 10 a.m. in the Police Jury meeting room with the following members **PRESENT**: James B. The Vernon Parish Police Jury was convened as the governing authority of the Parish of Vernon, by Mr. James B. "Jim" Tuck, President, and was then ready for the business on the agenda.

The invocation was given by Mr. Curtis Clay and the Pledge of Allegiance was led by Mr. Cody Hostetler.

The President asked if there was any public comment on any agenda items; there was none.

The President asked for committee reports to be presented by the committee Chairman.

Mr. Cody Hostetler, Chairman, Economic Development & Planning Committee, reported that the committee met on Monday, March 11, 2024 at 5:00 p.m. in the police jury meeting room.
